

Bill and June Flatt Outstanding Faculty Extension and Outreach Award

Purpose

To recognize exceptional creativity and scholarship in the development, application, and evaluation of extension, outreach, and public service programs that benefit the residents of Georgia.

Eligibility

One award will be given to a tenured/tenure track faculty member

Past recipients are not eligible for the subsequent three years.

Nominations

Each department and unit of the College is eligible to nominate one person for the Bill and June Flatt Outstanding Faculty Extension and Outreach Award. The nominations are to be made through the following departments or units:

- Financial Planning, Housing and Consumer Economics
- Foods and Nutrition
- Human Development and Family Science
- Textiles, Merchandising and Interiors
- Institute for Human Development and Disability

How to nominate

Each department and unit may submit the dossier of one nominee selected by a committee at the department or unit level.

The nominations for the College review shall consist of:

- 1. One (1) internal letter of nomination. Nomination letter detailing the nominee's outstanding achievements in the areas of extension, outreach, and public service. The letter of support should draw attention to the significance of the individual's work as it relates to the award criteria.
- 2. One (1) external letter of support. This letter from someone outside the unit/department should be selected based on the logic of the award, e.g. student letter for teaching or advising award or mentoring research; alumni letter (former student); constituent or beneficiary for a public service and outreach and Extension award; peer or colleague researcher for research award; etc. The letter of support should draw attention to the significance of the individual's work related to the award criteria.
- 3. Updated curriculum vitae. Abbreviated vitae highlighting accomplishments demonstrating excellence as related to the award criteria. (20-page limit).
- 4. Three to five examples of relevant supporting materials documenting program impact may be submitted. Examples of supporting materials could include items such as impact reports, outcome reports, journal articles, book chapters, curricula, and papers presented.

Nominations can roll over for up to three (3) years. The department or unit must email facsdean@uga.edu by the award deadline each year to confirm if a nomination is being rolled forward for consideration. Letters of support do not have to be updated yearly. It is at the department/unit's discretion to replace letters of support.

The recipient will be recognized at the annual Celebrating Excellence Awards Luncheon with a plaque and cash award. A plaque containing the names of honorees will be placed in Dawson Hall.

<u>Criteria</u>

- 1. Superior quality and innovative approaches to program delivery with maximum benefit to audience, community, and stakeholders.
- 2. Successful and sustained leadership in identifying and initiating programs and initiatives specifically targeted toward high-priority programs.
- 3. Effective communication of program results and impact.
- 4. Other evidence of support through partnerships, funding, and visibility of program reach and effectiveness.
