# DESIGN STATEMENT

THE CONCEPT, SEAMLESS EXPERIENCE, IS A COMBINATION OF SLEEK DESIGN THAT LOOKS AND FEELS EXPENSIVE, WITH THE EASE OF CIRCULATION ALL COMING TOGETHER TO GIVE AN EXPERIENCE IN THE HOME. THE USE OF NEUTRALS AND CONTRASTS BETWEEN THE WHITE MARBLE TILE AND THE BLACK MARBLE TILES ADDS DEPTH TO THE SPACE. THE ARCHED OPENINGS AND ARCHED SHOWERS SOFTENS THE SPACE TO CREATE THE SEAMLESS FLOW FROM THE SHOWERS TO THE VANITY AREA. BEFORE ENTERING THE SHOWERS, YOU ARE ABLE TO CONTROL THE TEMPERATURE AND WATER PRESSURE THROUGH A DIGITAL DIAL WITHOUT GETTING WET. HAVING THE SHOWERS IN A SEPARATE SPACE FROM THE REST OF THE BATHROOM CREATES A SPA LIKE FEELING BY BEING ENCLOSED IN THE SPACE. WHEN WALKING OUT OF THE SHOWER, THERE IS A WARMING TOWEL RACK TO THE LEFT BEFORE HEADING INTO THE SEPARATE VANITY AREA. THE COMPLETELY SEPARATE VANITIES ALLOWS YOU TO EACH HAVE YOUR OWN EXPERIENCE IN THE BATHROOM WHEN GETTING READY FOR A BIG DAY. THERE IS ALSO A DEDICATED SPACE FOR A STOOL AND VANITY DRAWER FOR OTHER RESIDENCE TO GET READY. THE DECISION TO CLOSE OFF THE WINDOWS ON THE ANGLED WALL ALLOWS FOR THE COMPLETELY SEPARATE VANITIES TO BE POSSIBLE. STORAGE IS NO ISSUE IN THIS SPACE DUE TO THE FLOOR TO CEILING CABINETS LOCATED AT EACH VANITY. A LARGE SOAKING TUB WITH WINDOWS AROUND ADDS TO THE SPA LIKE FEEL IN THE ROOM.

IN CONCLUSION, THE USE OF MARBLE MATERIALS, IMPLEMENTATION OF SOFT EDGES, AND THE SEARATION OF THE SPACES ALL COMES TOGETHER TO ENHANCE THE SEAMLESS EXPERIENCE IN THE HOME.


