^{*}Faculty Awards standard nomination packet is to include one (1) internal letter of nomination. Nomination letter detailing the nominee's outstanding achievements in the areas of extension, outreach, or public service. The letter of support should draw attention to the significance of the individual's work as it relates to the award criteria; one (1) external letter of support. This letter from someone outside the unit/department should be selected based on the logic of the award, e.g. student letter for teaching or advising award or mentoring research; alumni letter (former student); constituent or beneficiary for a public service and outreach and Extension award; peer or colleague researcher for research award; etc. The letter of support should draw attention to the significance of the individual's work as it relates to the award criteria; and updated curriculum vitae (or resume).
