David Alito is the SPEC area Director in Atlanta. In this role, he is responsible for maintaining and establishing partnerships with key stakeholders in 16 states along the East Coast, plus Puerto Rico and the District of Columbia. The focus is on assisting taxpayers in satisfying their tax responsibilities through the Volunteer Income Tax Assistance and Tax Counseling for the Elderly programs.

Prior to this position, David was the Wage and Investment Division (W&I) Deputy Commissioner. In this role, he assisted the W&I Commissioner in overseeing all W&I organizations. W&I has approximately 37,000 employees and is responsible for the provision of customer service (including on-site and telephone assistance) and the processing of tax returns for all United States taxpayers, as well as compliance activities pre-refund for W&I taxpayers.

David began his IRS Career in 1987 as a tax examiner in the Atlanta Service Center. Throughout his career, he has held positions in a variety of Compliance functions, including Director, Filing and Payment Compliance and Director, Collection. And, in the W&I Division, he has served as the Director, Reporting Compliance and the Director, Compliance.

A native of Binghamton, NY, David studied at the University of Florida in Gainesville, where he earned a bachelor's degree in political science. David is a graduate of the May 2003 IRS Executive Development Program.

Maryann Enciso is the Director for Stakeholder Partnerships, Education and Communication "SPEC" in the Wage and Investment Division. In this role, she is responsible for the delivery of tax education, free return preparation services and financial education to our nation's low-income, elderly, disabled, Native American, non-English speaking and rural taxpayers. Prior to this position, Maryann served as the Field Assistance Area 4 director.

Maryann received her master's degree in Business Administration and her Bachelor of Science degree in Workforce Education and training from Southern Illinois University. She received her Associates Degree from the Community College of the Air Force in Human Resource Management. She retired from the California Air National Guard as a Chief Master Sergeant (E-9) as a Senior Human Resource Advisor. Prior to that, she served 9 years as a First Sergeant responsible for numerous deployments and taking care of the enlisted personnel on the base. Maryann is a graduate of the 2018 Senior Executive Service Program.

Maryann's career began with the IRS in 1992 as a GS-4 Taxpayer Service Representative. She was promoted to Field Collection in 1994 and joined the management ranks in 2004. She was selected as an SB/SE Field Collection Territory Manager in 2009. Prior to joining IRS, Maryann served 10 years on active duty with the United States Marine Corps.
