The designation is administered through Real Estate Financial Modeling, a training company out of Atlanta. Since its inception in 2011, the number of REFM certification holders has risen an average of 76% year-over-year, making it one of the most sought-after credentials within the real estate profession. At year-end 2022, approximately 6,500 individuals had completed Level 1 and 5,000 had completed Level 2.  - *The Certified Analytics Professional (CAP®) certification is internationally administered by the Institute for Operations Research and the Management Sciences, commonly known as INFORMS. Established in 1995, INFORMS is made up of 12,500 members internationally, and is one of the foremost associations for professionals in operations research, analytics, management science, economics, behavioral science, statistics, artificial intelligence, data science, and applied mathematics. The CAP exam is made up of 100 questions, and passage of the exam requires at least 70% correct responses. INFORMS internal records show 50% of exam takers pass the first time, while only 40% of second-time takers ultimately pass. First introduced in 2013, CAP has since been recognized by CIO magazine and Indeed as currently one of the top professional analytics certifications in the world. The CAP exam is vendor- and technology-neutral. The exam is subdivided into seven knowledge domain components: (1)business problem framing; (2)analytics problem framing; (3)data; (4)methodology; (5)model building; (6)model deployment; and (7)lifecycle management. As of January 2023, there were 614 CAP certificate holders from 40 countries.  - *The AICP designation is the highest administered by the American Planning Association, a group of urban planning and development professionals and officials with a total membership of 40,000, spread out across 90 countries. Of that number, 17,000 have earned the AICP designation, an independent verification of planners' qualifications and a testament to individual competence and ethical integrity within the industry. As of June 2023, there were 468 AICP designees within the state of Georgia, with 21 based in Athens. The AICP exam consists of 170 multiple choice questions, which requires roughly 73% correct responses covering such core areas as fundamental planning knowledge, research and assessment methods, and planning policy development.  - *The Praxis Exam II for Economics is one of a handful of subject-based post-graduate exams that are administered by the Educational Testing Service (ETS), perhaps the preeminent testing organization in the country. The Economics Exam measures general knowledge of economics across a broad spectrum, and denotes economic proficiency as a subject matter. ETS statistics confirm that the 2018 cohort group encompassed 375 Praxis Economics Exam test takers, with an average score of 152 and an interquartile range of 140-164. My score places me within the 97th %ile.  - *LinkedIn began offering its skills assessments in 2019. In a short time, however, the professional networking platform has seen extraordinary growth internationally in the number of people who have taken these tests as a way of demonstrating their technical/computer software skills. As of July 2023, the total number of assessment takers for each of the skills listed above were: a) MS Excel (29.0 million); b) MS Word (11.5M); c) MS PowerPoint (10.8M); d) MS Outlook (5.5M); e) Accounting (4.8M); and f) Machine Learning (1.5M). The first edition of the *Introduction to Housing* textbook was adopted for housing-related courses in at least 47 academic institutions outside of UGA from 2005-2014, with 34 of these schools confirmed as repeat adopters. This covers an estimated 4,200 students in over 140 separate college classes using the textbook during that time. Many of the adopting institutions are non-HERA member institutions, which suggests fairly broad interdisciplinary appeal. The textbook can also be found housed in 72 college and university libraries. - Some of the academic journal articles and books mentioned earlier have been singled out for various awards and recognition. The following represents descriptions of these honors:

- For both 2020 and 2021, it was reported that the 2019 Moore/Carswell/Worthy/Nielsen *FCSRJ* article on student housing was among the top 10 most downloaded archived *FCSRJ* articles. For perspective, this covers the journal’s entire content which encompasses an estimated 1,800 articles dating back to 1972.
- Two of my articles within *Family and Consumer Sciences Research Journal* have been cited as “Best Paper” within the Housing and Interior Design track during their respective years of publication. This designation applied to the Skobba/Carswell 2014 *FCSRJ* article on community land trusts, as well as the Hopkins/Carswell/Love 2020 *FCSRJ* article on ENERGY STAR appliances and multifamily rents.
- The *Encyclopedia of Housing (EoH)* has received the following prestigious awards from within the publishing industry:
 - American Library Association’s RUSA “Outstanding Reference Sources List” award
 - *Library Journal*’s “Best Reference of 2012” award
 - About.com’s “Essential Reference Books for Architecture”

Regarding the first two awards, issued in early 2013, the encyclopedia claims a notable distinction within the reference publication industry (which includes encyclopedias, dictionaries, almanacs, anthologies, and chronicles). In a publication niche such as this one, which produced well over 1,000 titles in 2012, *EoH* stands alone as the only publication to claim both of these awards. The About.com selection of *EoH* is one of six books total chosen from the late 20th century to present day.

- In May 2010, Emerald Publishing issued its “Highly Commended Award” to the Carswell/Smith article in the *Journal of Engineering, Design & Technology*. The award was determined through an independent panel of publishing and academic judges, and represents approximately the top 20% in terms of quality for that journal’s 2009 articles. - Since its publication in mid-2012, the *Encyclopedia of Housing* has achieved a few sales landmarks that are worth noting, which are listed below.

As of December 2022, the encyclopedia was housed in a number of libraries. The following is a sampling of the types of libraries that have purchased and adopted this publication in either print or e-book format for their collections (sources: WorldCat, LibDex, Lib-Web-Cats, Library of Congress, Librarydir.org, and several country/state specific online public access catalogues, or “OPACs”):

- *More than 1,100 public and private four-year colleges/universities within the U.S., with over 85% of the classified “Research I” institutions included within this list. Geographically, these schools cover all 50 states, plus DC, Guam, Puerto Rico, and the Virgin Islands.*
- *Over 550 international college and university libraries outside the U.S., representing 96 different countries across 6 continents.*
- *Several national libraries (China, the Czech Republic, Denmark, Great Britain, India, Israel, Japan, Latvia, Malaysia, Netherlands, Qatar, Saudi Arabia, Scotland, Singapore, Slovenia, South Africa, Sweden, Taiwan, and Wales), plus U.S. Library of Congress and an agency of the European Union (EU)*
- *Over 350 community colleges or 2-year academic institutions in the U.S. and Canada*
- *Over 200 other libraries, mostly state, municipal, public, corporate and nonprofit libraries, both in the U.S. and abroad*
- *Given the interdisciplinary nature of the encyclopedia, a number of specialty libraries have purchased the reference book, including: 20 architectural/design libraries; 10 business school/economics libraries; 11 law libraries; 8 medical/health sciences libraries; an international development bank (in South Africa); a multinational engineering firm (India’s Larsen & Toubro, Inc.); and a consumer research institute in Norway.*

As of year end 2021, total gross sales revenue for the book is estimated at over \$900,000, based on sales price and volume information from a variety of sources (SAGE Publishing, BookScan, Amazon.com, WorldCat, LibDex, Lib-Web-Cats, Library of Congress, and several country/state specific OPACs).

As of year end 2019, the encyclopedia had attained a few notable sales milestones when compared against similar publications. When using WorldCat library adoption tallies as a proxy for overall sales, the following comparisons can be made regarding unit sales and sales revenue:

- *Ranked in the top 2% for unit sales and in the top 3% for gross sales revenue of all subject-based encyclopedias published in 2012 [Note: N=874 for such publications; WorldCat advanced search parameters include “title: encyclopedia”, “format: book”, “year: 2012”, “content: non-fiction”, and “audience: non-juvenile”; sales revenue figures incorporate the publisher’s listed book price]*
- *Ranked #4 in unit sales and #1 in gross sales revenue for all housing-themed publications released in 2012. This list includes all domestic and international non-fiction books (reference, academic, textbook, professional, and current affairs) related to housing, which represents an estimated universe of over 1,000 publications. [Note: WorldCat advanced search parameters include “keyword:housing”, “year:2012”, title:“housing” OR “homes” OR “mortgage(s)” OR “houses” OR “homeless(ness)”, “format:book”, “content: non-fiction”, and “audience: non-juvenile”; sales revenue figures incorporate the publisher’s listed book price]*

- A number of my students who have completed the FHCE 5320 course go on to complete the Real Estate Financial Modeling (REFM) Level I Exam. REFM is a respected certification and training firm for thousands of real estate industry members, primarily commercial and multifamily. Students who successfully complete this exam show a demonstrated ability to understand intermediate level Microsoft Excel commands, models, and functions in fairly complex real estate finance applications. During a recent semester (Fall 2019), 20 out of 27 students (74%) successfully completed the REFM Level I exam, with 12 of those students passing the exam “with distinction”.
